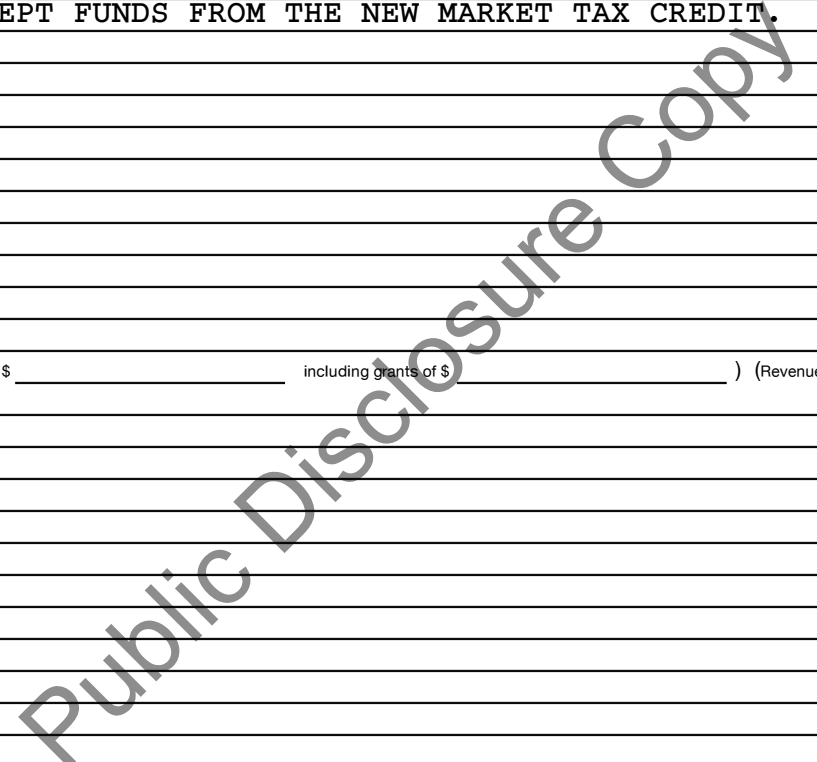

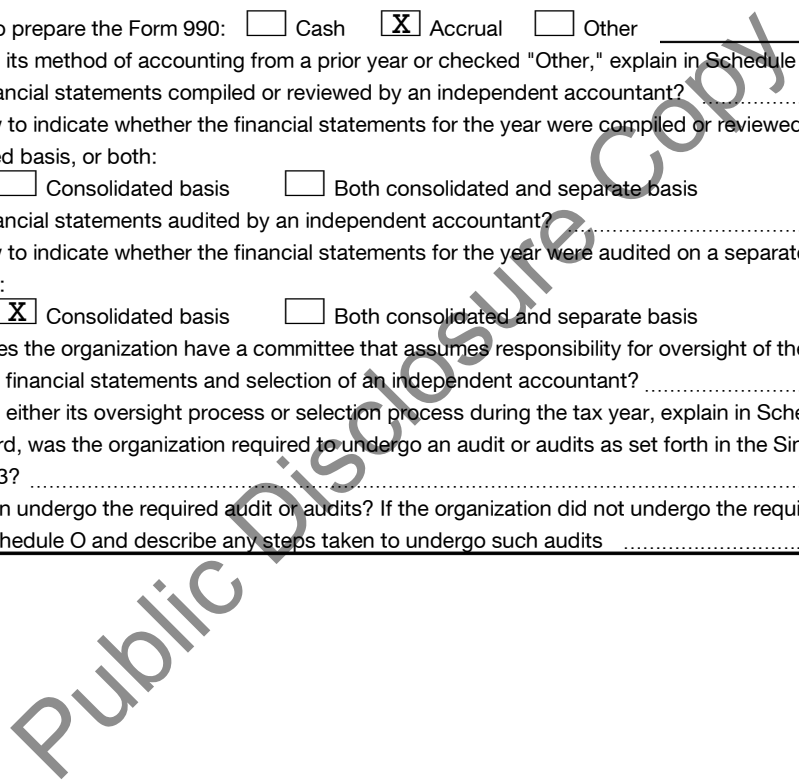

THE PURCHASE PRICE OF THIS LEASEHOLD INTEREST WAS \$5,425,000, OF WHICH \$5,118,401 WAS PAID IN CASH AND FINANCED THROUGH THE QCLI LOANS AND \$306,599 WAS DEEMED A CONTRIBUTION FROM THE MUSEUM.
